### Access to continuous glucose monitoring (CGM) through the NDSS:

Subsidised access to CGM products is open to:

- Children and young people with conditions very similar to type 1 diabetes who require insulin; and
- Children and young people, under 21 years of age, with type 1 diabetes; and
- Women with type 1 diabetes who are actively planning pregnancy, pregnant or immediately post-pregnancy; and
- People with type 1 diabetes aged 21 years or older who have concessional status and have a high clinical need to access CGM products.

To gain access to subsidised CGM products, the individual will need to be assessed by an authorised health professional to determine if they meet specific eligibility criteria.

The eligibility categories and criteria are listed on the Continuous Glucose Monitoring Eligibility Assessment form, available at [www.ndss.com.au/cgm](http://www.ndss.com.au/cgm)

A Continuous Glucose Monitoring Eligibility Assessment form cannot be accepted by an Access Point. It must be submitted as per the instructions on the form.

CGM sensors and transmitters can be ordered through the NDSS Access Points.

Sensors are available in boxes of four or five, and each sensor operates for six or seven days, depending on the model. Transmitters are supplied individually, and will operate for three months, six months or 12 months, depending on the model.

There is no copayment required for CGM products.
